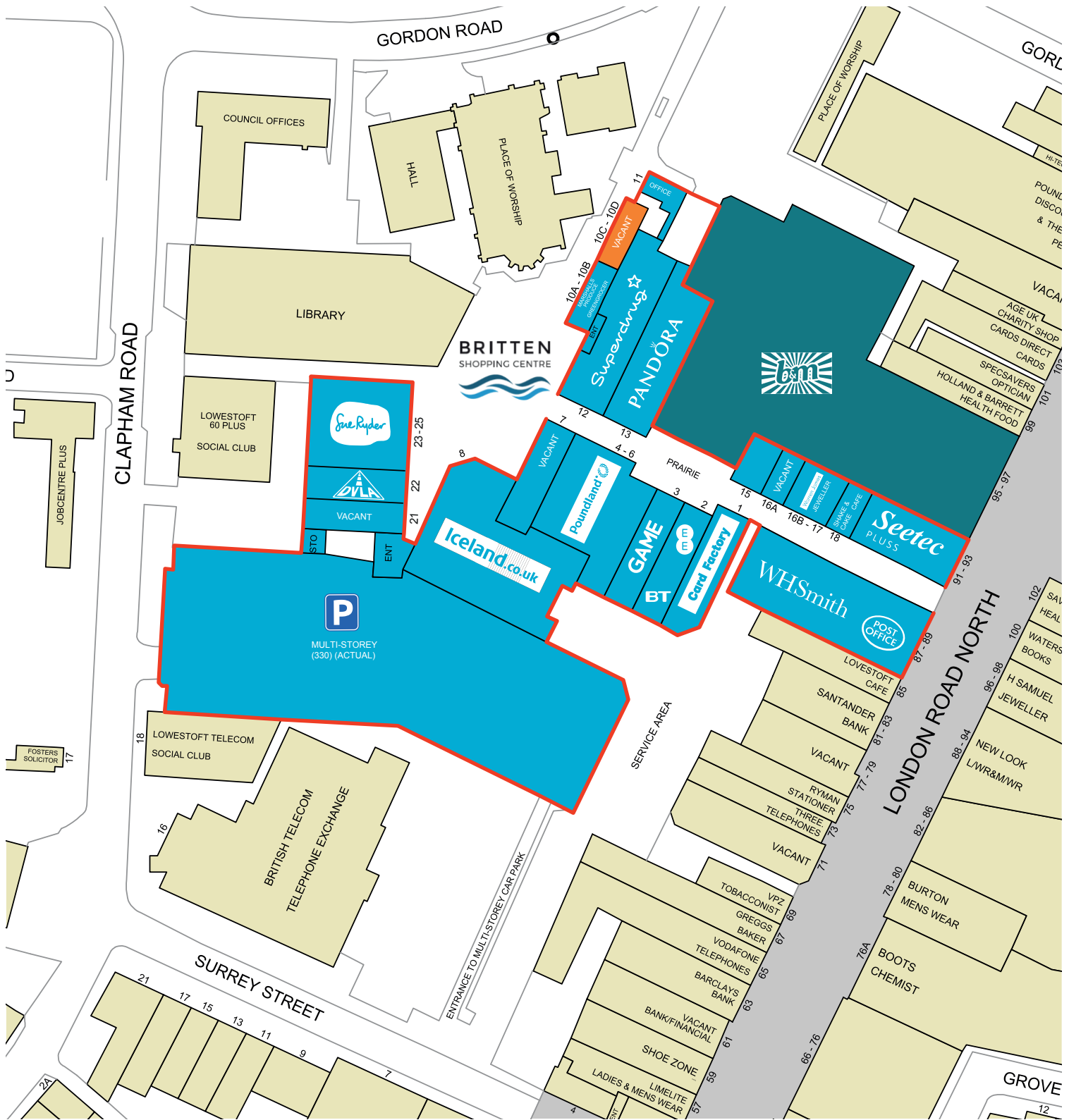
Planning
